### Corporate Membership Program at the Vandalia Recreation Center

A Vandalia Recreation Center Membership provides you complete access to the facility's Fitness Center, Aquatic Center, Gymnasium and Track during regular operating hours and discounts on classes and programs. A **RESIDENT** is defined as any person who resides within the corporate limits of the City of Vandalia. Since the city and school district boundaries are not the same, this is not to be confused with being a Vandalia-Butler School District resident. Proof of residency is required to qualify for resident membership.

A **BUSINESS** is defined as any head of household or spouse that does not reside in the City of Vandalia, but works within its corporate limits. Your company ID or pay stub with valid photo ID must be presented at the time a pass is purchased.

A **NON-RESIDENT** is defined as any person who does not reside within the corporate limits of the City of Vandalia. While your mailing address may be Vandalia, this does not always qualify you as a City resident.

A **FAMILY** is defined as a married couple or single adult and any children (17 years of age or younger and/or still in high school) residing in the same household and claimed on their most recent federal income tax return. Any child attending a university or college full-time may be included in a family membership with proof of enrollment. (Federal tax return or birth certificate is required at the time of purchase.)

A **DUAL MEMBERSHIP** consists of any two people residing in the same household. Both parties must provide proof of residency such as valid driver's license, utility bill or recent tax forms.

An **ADULT** is defined as any person, eighteen (18) years of age or older.

A **YOUTH** is defined as any person, ages 5 - 17 years of age, or current high school student.

A **SENIOR ADULT** is defined as any adult age 62 or older for purchase of memberships only.

To obtain the 15% discount, your Montgomery County employee ID badge or recent pay stub must be presented to the Front Desk Attendant when signing up or renewing your membership.

### Electronic Funds Transfer (EFT)

- Convenient, automatic monthly payment taken from your checking or savings account.
- Automatically renews your membership each year.
- A \$50 cancellation fee will be applied if you cancel your EFT (Electronic Fund Transfer) before your anniversary date.
- Notice of cancellation must be made in writing.
- Monthly withdrawals are taken out the 15<sup>th</sup> of each month, or the closest business day to the 15<sup>th</sup>.
